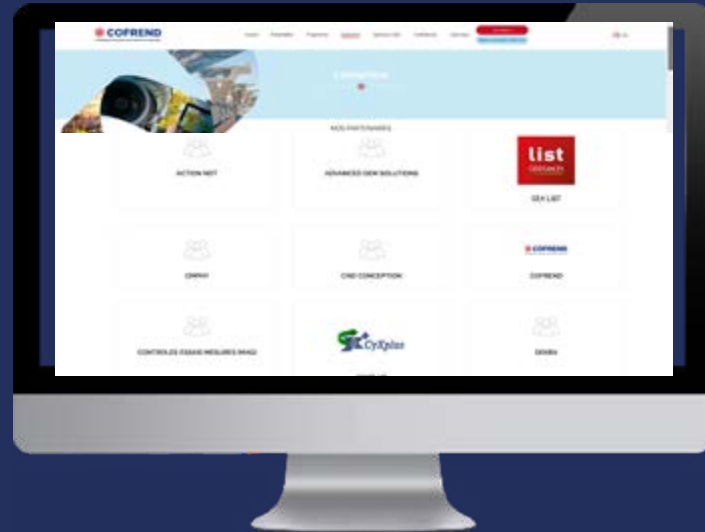

GENERAL REGULATIONS OF THE COFREND EXHIBITION

> ART. 1 DATE, PLACE AND DURATION

The 2023 COFREND Days will be held at the Event and Conferences Centre «Palais Chanot» in Marseille, from June 6th to 8th, 2023. The Exhibition will be open to the visitors from Tuesday June 6 to Thursday June 8 included.

> ART. 2 REGISTRATION, PAYMENT

To be valid, a registration must be made together with a 30% provision on the total amount due. The balance to be paid upon reception of the invoice and, whatever the circumstances, three months before the beginning of the event. In case no payment is received by the stated dates, the registration shall be cancelled. The Organiser decides on acceptance or rejection with no obligation to specify the motives of the decision. Rejection of a request shall not give rise to the payment of any compensation other than the reimbursement of the sums paid to the Organiser.

If, in case of force majeure (fire, explosion, war, strike, pandemic etc) independent of the Organiser, the Exhibition should not take place, the sums paid by the Exhibitor would be kept by COFREND.

> ART. 3 ALLOCATION OF BOOTHS

Registration forms shall be numbered as they arrive.

The map of the Exhibition shall be sent to the Exhibitors after approval by the Security Commission of the Palais Chanot Congress Centre.

Distribution of spaces will be made taking into account the order of arrival of registrations.

The Organiser is entitled to modify a rented space an allocated place, at any time if he considers it necessary according to the number of registrations. If the modification concerns the rented surface, the price of the booth shall be accordingly reduced.

No claim shall be accepted from the Exhibitors on allocated spaces.

OFFICIAL CATALOGUE

An official catalogue will be printed. The Organiser is not liable for errors or involuntary omissions that may occur.

> ART. 4 MODIFICATION OF BOOTHS

The Organiser has the right to suppress or modify a non-complying installation that has not been preliminarily submitted to him.

> ART. 5 OBLIGATION OF THE EXHIBITOR

Registration implies acceptance of the current regulations, of the specific Palais Chanot Congress Centre regulations and of Safety regulations prescribed by the Authorities.

Any violation of these rules may cause immediate, temporary or final exclusion of the Exhibitor without any compensation or reimbursement of the sums paid.

The Exhibitor is allowed to display on his place only equipment, products and services listed upon registration and accepted by the Organiser as corresponding to the scope of the event. He will not advertise in any manner for non-exhibiting companies.

DISPOSAL OR SUBLEASING CONDITIONS

It is forbidden to give or sublet all or part of the allocated space. However, collective booths may be organised after approval by COFREND of the principle and the name of each participant; each

of these booths is to be mounted by a coordinating exhibitor, alone liable in front of COFREND. Exhibitors shall not obstruct aisles nor occupy them or in any manner disturb their neighbours. Booths shall be permanently occupied by a competent person during the Exhibition opening hours.

It is forbidden to deteriorate or cut in any manner the separations, ceilings and floors of the booths as well as any equipment provided by the Organiser. Any violation would cause the Exhibitor's full liability in case of deterioration, accident or nuisance to the neighbours.

Additional night surveillance, affected to one booth can only be subscribed by the exhibitor to the Surveillance company selected by the Organiser.

> ART. 6 ABSENCE OF OCCUPATION

Spaces that remain unoccupied upon the opening may be allocated to another exhibitor, without any acceptable claim from the absent Exhibitor for any compensation or reimbursement.

> ART. 7 PUBLICITY

It is forbidden to place equipment, panels, signs or leaflets outside of the booths.

In case of violation, the Organiser shall remove at the Exhibitor's expense and risk and without any warning the elements placed in spite of the current regulations.

> ART. 8 OCCUPATION OF BOOTHS

Only short receptions are permitted at the booths on condition that aisles or neighbouring booths are not obstructed. Booths must be kept in a constant state of impeccable cleanliness.

Sales are strictly forbidden.

> ART. 9 MOUNTING

Installation will start on Monday 5 June, 2023.

Whatever the circumstances, the booths shall be completely fitted by Tuesday 6 June at 8.00 a.m. for the official technical and security inspection. During the Exhibition and until Thursday 8 June 2023, it is forbidden to deliver or take out equipment.

> ART. 10 DISMOUNTING

The Exhibitor or his duly authorised representative shall be present at the booth from the beginning of dismantling to the complete evacuation of the booth.

After the stated time, the Organiser can have the objects remaining in the booth transported in a storage place of his choice, at the Exhibitor's expense and risk and without being liable for any complete or partial damage.

DAMAGES

Exhibitors shall leave the spaces, decorations and equipment made available to them in their initial condition.

Any deterioration caused by their installation or goods either to the equipment or to the building or else the floor occupied shall be estimated by the architects and charged to the Exhibitors.

> ART. 11 SAFETY MEASURES

In what concerns installation of booths, materials that can be used, and in general, safety measures to be complied with, exhibitors are required to conform to the provisions included in articles R 123-1 to R 123-55 of the code for construction and habitat, to the June 20 1980 decree, the No-

vement 18 1987 decree, relative to the protection against fire and panic in facilities hosting public, as well as to any other statutory and regulatory provisions in force at the time of the Exhibition. Opening permission may be rejected for booths which do not meet the regulatory safety prescriptions.

The Organiser is not liable for any decision made by the Security Commission to close a booth that does not comply with the regulations in force.

FORBIDDEN PRODUCTS

Explosive materials and, in general, all hazardous products are not allowed.

The operation of instruments, distribution or installation of objects likely to cause nuisance or hazard to other exhibitors or to visitors are also forbidden.

Machines for demonstrations: all machines for demonstrations must be fitted with a safety device and be insured, whatever the circumstances.

INDUSTRIAL PROPERTY

The Exhibitor is in charge of ensuring industrial property of the equipment or products exhibited by him, in conformity with statutory provisions in force, (such as the request for a French patent).

These measures shall be taken before the presentation of those equipment or products, the Organiser rejecting any liability in this matter.

> ART. 12 MANDATORY INSURANCES

Exhibitors are required to buy at their own expense an "All risks insurance" and Public Liability insurance from their insurance agent or from the Organisers'.

The organisers of collective booths have the obligation to make each of the exhibitors contract insurance covering the fore-mentioned risks.

The Organiser is considered free from any liability and specifically in the case of loss, theft, or any kind of damage.

> ART. 13 CANCELLATION

No request for cancellation, whatever the motive, shall be examined.

The sums paid will remain, whatever the circumstances, the property of COFREND.

> ART. 14 JURIDICTION

In case of claims, disputes, express agreements between parties, only Paris Law courts are competent, even in case of a plurality of counsels for the defence.

CONTRACTUAL DOCUMENTS

Only the documents written in French language, including the current regulations, are the authentic version. Translations in foreign languages are only indicative.
